# "A Beacon of Hope: PCC's Impactful Aid to Tajinder Kaur"

I, Tajinder Kaur, a sociopreneur and entrepreneur, run a public service center in rural Amritsar, India, and a tech startup in Vancouver. With a background from Brunel University and NMIMS, I have been a key player in emerging tech for 15 years, focusing on AR, VR, MR, AI, IoT, and Blockchain. Balancing C-suite engagements with community service, I exemplify leadership through data-driven decision-making and pursuing a Ph.D. in social work and policy-making.

I graduated with BSC in International Business from Brunel University in 2012. After graduation, I secured a job with a technology product-based SME in New Delhi, India. I worked as an Inside sales executive in Delhi & Bangalore branches for 2 years from 2012 – 2014.

Post-resignation, freelanced for 2 years (2014-2016) as a trusted tech vendor in Delhi, leveraging leadership skills from UK education. Effortlessly transitioned to entrepreneurship, running The Kaur Research for 4 years (2018-2021) by successfully engaging clients globally in lead generation, C-level meetings and deal closures.

My Entrepreneurship journey and International Business degree from UK made me gain an invitation as a guest lecturer at their confluence in 2020 at Amity University, Noida, India. I also wrote a book as a ghost author on marketing automation.

At present, I am a CEO & Founder of LadderClimb a startup based out of Vancouver, Canada, which is an exclusive professional platform for C-suite, Techpreneurs, Investors and Mentors.

I am a sociopreneur, a founder of the Rotary Skill Center in rural Amritsar, Punjab, India.

I got married and moved to the rural Punjab area, I witnessed 10s of youths die of drug addiction in our village Amritsar, Punjab and I wanted to find the root cause of the same. Idleness & and unemployment were the main causes behind most of the people who were getting into drug addiction or suicide. We are engaging them in a stitching center, computer centre & a public library to learn and get certified by Rotary International Amritsar, Punjab, India. Punjabi Chamber of Commerce helped us to start this centre by becoming a bridge between Rotary and our village welfare. It started by sharing my areas of concern and the ideas to tackle them with Team PCC, who then connected me with the PCC Amritsar Chapter Co-chair. Thereafter all steps got aligned and with the support of PCC I finally got to sign a MoU with the Rotary Club seamlessly.



- Conducting Sikhi education campaign for village teenagers and kids, I gather them at Gurudwara Sahib, sharing Sikh history and Guru Gobind Singh ji's sacrifices. The initiative includes quiz contests, open mics, and tests, with enthusiastic kids prepared to speak on Sikhi at any stage.
- Stitching center, handcraft art. Entrepreneurship skill development, computer center and a public library in a rural Punjab area that is affected by drug addiction in youth of Punjab, India.
- Recognized as a sociopreneur through Rotary Club Amritsar, Punjabi Chamber of Commerce, and Textile Manufacturing Association in Amritsar, I've established a training center fostering entrepreneurship and empowering women in rural Punjab. By offering stitching skills and orders from various sectors, we're aiding unemployed females, particularly those affected by the drug epidemic or unemployment among male family members.
- Operating a computer center within the social service center, I provide essential computer skills to underprivileged teenagers, youth, and adults. Collaborating with national and international channels, we facilitate remote job opportunities. Future plans include skill development in website design, social media and Google marketing, open mic activities, podcasting, and art and handcraft development, offering a platform for rural talents to thrive.
- Establishing a public library to foster reading habits and provide companionship through books, villagers gather at my home, issuing Punjabi and English books. This achievement fuels my motivation to enhance rural areas, even on a smaller scale.



# ENABLING ORGANIZATIONAL CULTURE AND WORKPLACE POSITIVITY

Organizations strive for optimal productivity by implementing motivational tools and incentives. A key challenge is fostering workplace positivity, encouraging a positive mindset, openness to change, and effective teamwork. Collaboration among employees can lead to breakthrough results, although achieving this may initially seem utopian.

The pursuit of excellence involves fostering a culture of workplace positivity, where the interlinked dynamics of organizational culture and positivity are mutually reinforcing for synergistic outcomes.

Established research emphasizes the impact of culture on performance, urging a focus on fostering productivity and positivity-driven organizational culture. To engineer such a culture, organizations must consider the six primary work motives: play, purpose, potential, emotional pressure, economic pressure, and

inertia. Emphasizing play, purpose, and potential while minimizing emotional and economic pressures and inertia tends to vield better outcomes.

#### Road Map for Leaders

Senior leaders, akin to an organization's operating system, cultivate a high-performing culture through training managers in motivating leadership. CEOs play a crucial role in enhancing cultural elements, ranging from role design to performance reviews. They must:

- 1. Hold a reflection huddle with their teams once a week by asking: 1) What did they learn this week? 2) What impact did it have? & 3) What do they want to learn next week?
- 2. Explaining the why behind the work of their team?
- 3. Does everyone understand the impact of their work?

Though great culture is not easy to build, it leads to a powerful competitive advantage. Yet organizations that build great cultures are able to meet the challenges of the highly competitive business environment.

#### How to develop Positivity in Work Place

Positivity in workplace is a function of developing a positive attitude in the organization. This is possible only if we can develop the right perspective to work and how it is done. Leaders must:

- 1. Be encouraging and empathetic. Injecting optimism and encouragement into the workplace, benefits all.
- 2. Be a team player. Talk with all your stake holders, employees and co-workers to see how you can assist them.
- 3. Work with the right people. It will help you handle everyday stress in a more constructive way.
- **4. Focus on what's in your control.** Your mission at work is to get your job done as effectively as possible, so focus on the factors you can oversee.
- **5. Treat yourself positively.** Practice positive self-talk. If you start to think negatively, evaluate these ideas rationally. Developing an enabling organizational culture leading to positivity in workplace is not ad hoc or transactional but continuous work in progress for creating an excellent and resilient organization.


